



## GENERAL WAIVER OF LIABILITY

In exchange for the opportunity to participate in treatments, classes, events and activities offered by Canine Strong LLC, I state and agree as follows: I am aware and understand that there is always some unavoidable risk of injury involved when participating in activities with animals, including risk of injury to myself or my dog. I acknowledge the absolute responsibility to follow instructions, standards, guidelines and procedures established by Canine Strong LLC, its employee or agents, and I take full responsibility for my actions and the actions of my dog. I am voluntarily participating in Canine Strong LLC's treatments, classes, events and activities with the knowledge of the risks involved and hereby acknowledge and agree to assume any and all risks of injury, death, and/or property damage, to myself or my dog, whether caused by the negligence of Canine Strong LLC, its employees or agents, other participants, or otherwise. I hereby agree to forever release, acquit, discharge, and covenant to hold harmless Canine Strong LLC, its employees, or agents, from any and all actions, causes of action, and claims on account of, or in any way growing out of, directly or indirectly, all known and unknown personal injuries or property damage which I may have or hereafter have whether attributable to the negligence of Canine Strong LLC, its employees, agents or otherwise. This Agreement may be amended only by a written instrument signed by both me and Canine Strong LLC. BY SIGNING THIS AGREEMENT, I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTAND ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE COMPANY, EFFECTIVE AS OF THIS DATE.
